Previously known as Full Day/5.5 Hr Seminar)

2.5 Hr UPDATE/REFRESHER/GENERAL:

UNDERSTANDING & RESPONDING TO CHILD ABUSE & EXPLOITATION

Includes: Child Sex Offender Awareness Module – *Making Children, Families & the Church Safe*.
Required every three years after the completion of the 4 Hr seminar in order keep certificates current.

This seminar is also designed as a general information seminar for those who may not technically be obliged to undertake training, however, do so for their own information as well as being a part of a vigilant team designed to keep children and churches safe.

NT churches can access this module as a bridging component for those who fall in between annual face to face seminars conducted in Darwin pending the production of an updated 4 Hr On-Line filmed module.

ON-LINE SEMINARS:

ON-LINE BRIDGING SEMINARS:

BCSANT strongly encourage those who hold current TTE/RRHAN certificates in SA, or Teacher certificates in the NT to still complete the BCSANT level of training, however at a minimum must view the 30-minute On-Line Child Sex Offender Awareness (Making Young People, Families & The Church Safe) bridging intensive. Participants are required to complete and submit an assessment paper for this module. **No other training is accepted by BCSANT.**

ON-LINE RECORDED/FILMED 4 HR FACE TO FACE SEMINAR:

This option is currently suspended pending the filming and production of an updated version.

Designed for rural/isolated churches as well as for those who are genuinely unable to attend a face-to-face seminar.

This seminar comes with additional reading/support material and assessment papers.
The professional filming/production and ongoing management of On-Line modules continues to be funded by Baptist Insurance Services and Child Protection Solutions (CPS).
